## DESCRIPTION

**ENDO/ECTO GRANULAR** contains naturally occurring, beneficial microorganisms which may enhance the biodiversity of the soil ecosystem.

## GUARANTEED ANALYSIS

**ENDO/ECTO GRANULAR** granular inoculum consists of an 11 species blend of spores of Endomycorrhizal and Ectomycorrhizal fungi well suited to a variety of soils, climates and plants including herbaceous plants, shrubs, ornamentals, fruit and nut trees, vegetables, and turfgrass. Contains Endo species: *Glomus intraradices*, *G. etunicatum*, *G. aggregatum*, and *G. mosseae* 60,000 propagules per pound. Ecto species: *Pisolithus tinctorius*, *Rhizopogon villosulus*, *R. luteolus*, *R. amylopogon*, *R. fulvigleba*, *Scleroderma Cepa* and *S.citrinum* 110 million propagules per pound. These beneficial fungi colonize plant roots, expand into the surrounding soil, and greatly increase the roots ability to absorb water, nutrients, and improve yields.

## COMPATIBILITY

**ENDO/ECTO GRANULAR** is compatible with most fertilizers, but the benefits of **ENDO/ECTO GRANULAR** will be reduced when applied during the use of strong chemicals.

## APPLICATION

**NURSERIES:** **ENDO/ECTO GRANULAR** can be mixed into planting media before/during filling of pots or trays. Use 1 to 2 pounds per cu. yd. **ROW CROPS:** Inoculum can be banded in rows or side dressed before or during planting at a rate of 10 to 20 pounds per acre or broadcast at a rate of 40 to 60 pounds per acre. **TURF:** Apply during installation or aeration of turf using 1 pound per 2400 sq. ft. of turf. **TREES AND VINES:** Apply inoculum to the planting holes of trees and vines. Use a rate of 1 to 2 tbs. per gallon of planting size. **Ball and Burlap plantings:** Use .5 to 1.5 oz. per inch of stem caliper. **Cuttings:** Use .5 teaspoon under each cutting, or 1 to 2 pounds per cubic yard of planting media.

## STORAGE

Store in a cool, dry place. Avoid prolonged exposure to direct sunlight. Tightly re-seal after opening to preserve shelf life. Store between 35° and 80°F. Do not freeze.
